



ALUMINUM EXTRUSION AD/CVD

On March 5, 2024, the U.S. Department of Commerce (Commerce) announced its preliminary determination in the countervailing duty (CVD) investigation of aluminum extrusions from China, Indonesia, Mexico and Türkiye.

On May 2, 2024, Commerce announced affirmative preliminary determinations in the anti-dumping (AD) investigations of aluminum extrusions for 14 trading partners including China, Colombia, Ecuador, India, Indonesia, Italy, Malaysia, Mexico, Korea, Taiwan, Thailand, Türkiye, United Arab Emirates and Vietnam.

As a result of the preliminary determinations, Commerce has initiated collection of AD/CVD duties on all aluminum extruded products imported into the United States from the 14 countries cited. Collected duties will be returned to the IOR in the event that the case is dismissed, or exemptions are included in the ITC final determination whereby the product is no longer subject to AD/CVD.

What Do We Know?

- The AD/CVD amount varies by country (see table for rates)
- Duties will be charged to the importer of record (IOR) at the time of entry to the U.S.
- International customers will not be subject to any AD/CVD for ATS products

What Aluminum Items?

- All products produced from aluminum extrusions are sited in the current investigation, including heat sinks and assemblies required for electronics cooling
- Petitions have been filed opposing the AD/CVD on subassemblies (e.g. heatsinks) as well as exemption for aluminum extrusions that the domestic industry cannot currently provide
